# Access Your Benefits Today

The Florida Education Association (FEA) has recently released our new look for the FEA website [www.feaweb.org](http://www.feaweb.org).



You will no longer need the password sent to you with your card. You can simply click the "create new password" button; enter your member number, last name and select your local union from the dropdown menu.

You will have 2 options you can put in an email address and a temporary password will be sent to the email you provide, or you can omit from putting an email and a temporary password will display immediately.

Once the temporary password displays **use your mouse cursor to highlight and copy the temporary password**; then click the link that takes you back to the login.

Enter in your 10-digit membership number found on your Access membership card and **paste the temporary password you copied**. Once you are logged in you can scroll down the profile page and change your password to whatever you wish.

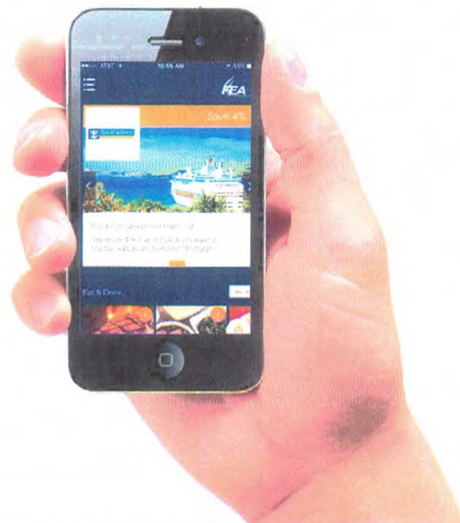

## Student Loan Forgiveness Navigator

### Frequently Asked Questions

#### What information do I need to complete the tool?

Here's what you'll need to complete the tool and get your student loan options:

1. **Social Security Number (SSN):**  
Your SSN is used by the Department of Education to determine your eligibility for different student loan repayment plans.
2. **Most Recent Tax Return or Tax Transcript:**  
Bring the first page of your most recent tax return or tax transcript.
3. **Servicer Login Info:**  
Your login information can include a username or email, a password, and anything else required to log into your student loan servicer's website (i.e., a PIN number). This information will be used to import your student loan details into Savi during the account setup process.

#### What is an income-driven repayment plan?

An income-driven repayment (IDR) plan sets your monthly student loan payment at an amount that is intended to be affordable based on your income and family size. There are a variety of IDR plans, including REPAYE, PAYE, IBR and ICR, each with their own unique rules. For example, the REPAYE plan caps your monthly payments at 10% of your monthly income. The Forgiveness Navigator includes all of your federal repayment plans, and does the math for you.

#### What are my options for student loan forgiveness?

As a teacher, there are a few key ways to get your loans forgiven:

1. **Public Service Loan Forgiveness (PSLF):**  
The PSLF Program forgives the remaining balance on your Direct Loans after you have made 120 qualifying monthly payments under a qualifying repayment plan while working full-time for a qualifying employer.
2. **Teacher Loan Forgiveness:**  
If you teach full-time for five complete and consecutive academic years in a low-income school or educational service agency, and meet other qualifications, you may be eligible for forgiveness of up to \$17,500 on your Direct Subsidized and Unsubsidized Loans and your Subsidized and Unsubsidized Federal Stafford Loans.
3. **Teacher Loan Cancellation:**  
Certain teachers can qualify for cancellation of up to 100 percent of a Federal Perkins Loan if you have served full-time in a public or nonprofit elementary or secondary school system and meet certain employment criteria.

# On Your Side if You're Out of Work



If you're a union member and are out of work due to strike, layoff, lockout or disability, there may be help available to you from Union Plus.

## Union Plus Credit Card Assistance

After three months as a Union Plus Credit Card holder\* you may be eligible to apply for hardship assistance grants\*\*, including:

- **Job Loss Grant** – Eligible cardholders who have recently suffered a layoff or involuntary job loss for at least 90 consecutive days may be eligible to apply for a \$300 Job Loss Grant.
- **Strike Grant** – Eligible cardholders who have been on a union-sanctioned strike or lockout for at least 30 consecutive days may be eligible for a \$300 Strike Grant.
- **Disability Grant** – Eligible cardholders who have been unemployed for at least 90 days and lost 25% or more of their monthly income due to a recent illness or disability may be eligible for a \$1,600 – \$2,700 Disability Grant.

## Save My Home Hotline

## Union Plus Mortgage Assistance

Union Plus Mortgage holders who have their mortgage for a year or more are eligible for interest-free loans and grants to help make mortgage payments due to disability, unemployment, lockouts or strikes. ## Insurance Premiums Waived

Union Plus Life and Accident Insurance holders' payments are waived for up to three months if you've been laid off, or are on a union-sanctioned strike or lockout for more than 30 consecutive days. Call **1-800-393-0864.**

## Free Legal Advice

Call your union for advice on matters regarding the layoff. For all other legal matters, you can get free expert advice, including a consultation of up to 30 minutes, under the Union Plus Legal Services program. Plus, you get 30% off most additional services.
